- Sanction is hereby accorded to the transfer of land measuring 72 1. Kanals and 11 Marlas (under the possession of Department of Youth Services and Sports), situated in village Braripora, Tehsil Handwara, to the Science and Technology Department, for establishment of an Industrial Biotechnology Park at Handwara, as per the Khasra-wise breakup given in Annexure to this Order.
- 11. In partial modification of Cabinet Decision No. 81/10/2016 dated 14-10-2016, read with Government Order No. 190-IND of 2016 dated 26-10-2016, sanction is also accorded to the utilization of land measuring 10 acres (80 Kanals), situated at Industrial Estate Ompora, Budgam, for establishment of the Biotechnology Demonstration Farms and Tissue Culture, instead of establishing an Industrial Biotechnology Park (IBPT), for which the land was allotted earlier.
