Interim arrangement to make the vacant Tehsils functional.

Government order No. 135- Rev (Gaz) of 2017 Dated:- 09.06. 2017

Whereas, on account of creation of a large number of new administrative units in the state, a number of Tehsils were without Tehsildars due to shortage of manpower; and

Whereas in order to make these Tehsils functional, the administrative department has to make arrangement immediately; and

Whereas, vide Government Order No.Rev(Gaz) 183 of 2014 dated 24.07.201, 53 qualified Naib Tehsildars were placed as I/C Tehsildars as a stop gap arrangement and to fill up remaining vacancies, 56 qualified Naib Tehsildars were asked to look after the work of Tehsildars; and vide Govt. Order No.106-Rev (Gaz) of 2017 dated 27.04.2017 33 qualified Naib Tehsildars were asked to look after the work of Tehsidars and after making these arrangements, a sizeable number of Tehsils are still without Tehsildars;

Whereas, the Financial Commissioner (Revenue) has notified the seniority list of Naib Tehsildars as it stood on 01.09.2013 vide order No.FC(A)200 of 2013 dated: 08/10/2013.



Therefore, in order to make the remaining Tehsils functional, the Naib Tehsildars forming Annexure-A to this order are hereby ordered to look after the work of Tehsildars against the posts of direct recruits, till they become available for posting, without any claim of seniority or monitory benefits purely as an interim measure of temporary arrangement for a period of six months or till direct recruits become available for duty, whichever is earlier. The above arrangement shall, however, be without prejudice to outcome of writ petitions, if any, pending before any competent Court(s) of Law and shall not confer any preferential right on any of the above Naib Tehsildars for their substantive

promotion as Tehsildars as and when made to accordance with the relevant rules.
