Subject:- Selection of candidates for undergoing training on the basis of Common Entrance Test conducted by Jammu and Kashmir Board of Professional Entrance Examination (BOPEE).

GOVERNMENT ORDER No. 57-Rev (NG) of 2017

Whereas, in pursuance to the Cabinet Decision No. 62/10/2012 dated **09.04.2012**, read with Government Order No. 98-Rev (NG) of 2012 dated **11.04.2012**, the Jammu and Kashmir Board of Professional Entrance Examination was authorized to select suitable candidates on the basis of written objective test/examination for undergoing Patwar Training Course; and

Whereas, the Jammu and Kashmir Board of Professional Entrance Examination advertised the posts vide advertisement No. BOPEE/Adm/PT-218/148-60/2012 dated **28.05.2012**, and after conducting written test, the Jammu and Kashmir Board of Professional Entrance Examination forwarded a merit list to the Revenue Department; and

Whereas, vide Government Order No. 259/Rev/NG of 2012 dated **10.10.2012**, **1500 candidates** selected by the Jammu and Kashmir Board of Professional Entrance Examination were deputed for undergoing Patwar Training in the respective Revenue Training Institutes of Jammu and Srinagar. However in respect of District Rajouri, the selection of one candidate namely Mr. Mustaq Ahmed S/o Lal Din was stayed by the Hon'ble High Court in SWP No. 1271/2012, titled Israr Bukhari V/s State of J&K & Ors and OWP No. 1191/2012, titled Amjad Khan V/s State of J&K & Ors; and

Whereas, the Hon'ble High Court disposed off both the Writ Petitions vide Orders dated **26.10.2015**, and **14.12.2015**. The Orders passed by the Hon'ble Court in each case are reproduced herein below:-

I. SWP No. 1191/2012

"Learned counsel for the petitioner seeks permission to withdraw the instant writ petition.

Dismissed as withdrawn along with connected MP(s).

Interim direction, if any, shall stand vacated."

II. SWP No. 1271/2012

"Learned counsel for the petitioner has moved an application for withdrawing the writ petition on account of the petitioner having been joined as Teacher, therefore, not wanting to pursue the above mentioned writ petition. Application is duly supported with an affidavit. In view thereof, the same is allowed.

Disposed of as such.

***Writ petition along with connected MP is
dismissed as withdrawn."***

Whereas, the stay order granted by the Hon'ble High Court on the selection of Mr. Mushtaq Ahmed stands vacated as a result of the dismissal of above said Writ Petitions vide orders dated **26.10.2015** and **14.12.2015**.

Now, therefore, sanction is hereby accorded to the deputation of Mr. Mushtaq Ahmed S/o Lal Din R/o Rajouri (*Roll No. 164015*) to Revenue Training Institute, Jammu for Patwar Training Course on the basis of the merit list already provided by the Jammu and Kashmir Board of Professional Entrance Examination. The other terms and conditions as laid down in Government Order No. 201-Rev (NG) of 2012 dated **13.08.2012**, shall remain unchanged. The Principal of the Institute shall ensure due compliance of the said terms and conditions while allowing the selected candidate to join for undergoing Patwar Training Course.
