Sir,

- That the Services Selection Board received an indent requisition from Revenue Department endorsement No: Rev/NG/15/2011 dated 27-04-2011 advertised 07 (OM=04, RBA=01, SC=01 and ST=01), posts of "Jr Assistant", (Revenue Department), District Cadre Budgam, in pursuance to the advertised vide Notification No 03 of 2012, (Item No 268).
- In response to the said advertisement notice candidates were called for interview who have qualified the Type Test on Computer Key Board.
- 3. On the basis of Type Speed, weight-age determined in accordance with selection criteria and the interview awards, a select list so framed on the basis of merit and placed before the 116th Board, which adopted the select list and asked the Secretary of the Board to forward the said recommendation to your department with such observations.
- 4. That accordingly, I am enclosing the select list as Annexure "A". The select list recommended herewith shall be subject to outcome of any writ petition(s) pending in any court of the competent jurisdiction.
- The concerned Selection Committee has taken some precaution(s) to ascertain genuineness of qualification/category certificates besides publishing the provisional select list and inviting objection, claims etc.
- However, one post under SC category and one post under ST category remained un-filled due to non-availability of eligible candidates under the said categories.
- 7. That the Board is devoid of any fool proof mechanism/ resources to verify the genuineness of qualification/ category certificates/Permanent Resident Certificate, -Resident of concerned District/Division:- for a period not less than 15 years except scheduled caste category; therefore, the Department shall have to do it confidentially from the concerned Universities/ institutions/ Departments as has been practice in all the government departments. The verification needs, to be done strictly in order to ensure that only genuine candidates get selected/appointed.

You are further requested, that in case any certificate/document during the course of verification turns out to be fake/ fictitious, the Board may kindly be kept posted with such outcome so that the Board initiates criminal proceedings against such candidate(s) who participated in the selection process on the basis of such fake and forged documents.

The Board will also convey the outcome of the verification and the consequential changes to the Department if any. The Board will consider providing substitute in case a selectee goes out of selection/ waiting list on such verification.
