The regularization will be subject to the following conditions:-

- 1. The said appointees have not been selected by any recruiting agency/or appointed in any other Government Department.
- 2. The allowances other than what was admissible/ due has not been drawn/paid to them shall be recovered.
- 3. The incumbents are working against clear vacancy/posts.
- 4. The said incumbents shall report to the Deputy Commissioner concerned who shall allow them to join subject to the production of following certificates/documents in original:-
 - (i) Academic/Technical Qualification Certificates.
 - (ii) Date of Birth Certificates.
 - (iii) Health Certificate issued by the Competent Authority.
 - (iv) Permanent Resident Certificate.
 - (v) Relevant Category Certificate (in case the candidate belongs to reserved category).
 - (vi) Certificate from General Manager, DIC concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.
 - (vii) The incumbents shall be initially on probation for a period of two years. The Deputy Commissioner concerned shall get the genuineness of technical/academic qualification, category certificate, if any, verified confidentially. If, on verification, the certificates produced by the appointee prove to be take or gorged, the appointment/regularization shall stand cancelled ab-initio.
 - (viii) The salary of the incumbents shall not be drawn and disbursed to them unless a satisfactory report about the verification of their character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Deputy Commissioner concerned besides establishing the genuineness of the qualification/category certificates.
