The appointee shall report to the Financial Commissioner, (Revenue), J&K, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- Academic Qualification Certificate.
- ii. Age and Health Certificate.
- iii. Permanent Resident Certificate.
- iv. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- v. All other relevant documents as are required under SRO-43/1994.
- vi. "No loan" certificate under self Employment Scheme from DIC concerned and Employment Department

The appointee shall be initially on probation for a period of two years in terms of Rule-6 of J&K Revenue (Subordinate) Service Recruitment Rules, 2009 and her confirmation is subject to the qualifying the Revenue Departmental Patwar Training Course. If, on verification, the certificate(s) produced by the appointee proved to be fake or forged, the appointment shall be cancelled ab initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Financial Commissioner, (Revenue), J&K.
