Subject: Acquisition of land measuring 03 Kanal 09 Marla situated at village Sarhooti, Tehsil Mendhar, District Poonch for construction of PMGSY Road namely Ari upper to Sarhooti.

Whereas, on the basis of indent placed by Executive Engineer, PMGSY (JKRRDA) Jammu, a notification under section 4 (1) of the J&K Land Acquisition Act was issued by Collector Land Acquisition (SDM) Mendhar vide No.SDM/LA/PMGSY/444-52 dated 30.03.2018 for land measuring 03 Kanal 09 Marla falling under various Khasra Nos. i.e 301, 301 Min situated at village Sarhooti, Tehsil Mendhar, District Poonch for construction of PMGSY road from Ari Upper to Sarhooti, calling upon the objections from the land owners/ interested persons, if any; and

Whereas, pursuant to the above notification, no objection was received from any one accordingly the case was recommended by Collector Land Acquisition (SDM) Mendhar vide No.SDM/LA-PMGSY/388 dated 11.10.2019 read with letter No.SDM/LA/PMGSY/46-47 dated 06.08.2021 to the District Collector (Deputy Commissioner) Poonch for issuance of declaration u/s 6 & directive u/s 7 of Land Acquisition Act, svt.,1990. The District Collector vide No.DCP/LA/1649 dated 21.10.2019 readwith No. DCP/LA/721-24 dated 18.08.2021, recommended the case for issuance of declaration u/s 6&7 of land Acquisition Act;and

Whereas, the Divisional Commissioner, Jammu vide No.502/3807/PMGSY/Sarhutti/Poonch/19/2602 dated 29.10.2019, endorsed to Financial Commissioner, (Revenue) J&K who vide No.FC-LS-5137/2020 dated 06.03.2020 forwarded the same to this Department for the said purpose; and

Whereas, the report furnished by Collector Land Acquisition (SDM) Mendhar, vide letter referred to above duly endorsed by District Collector Land Acquisition (Deputy Commissioner) Poonch has been examined and it has been found that no objection has been filed by any one against the proposed acquisition; and



Whereas, the Government is satisfied that the land particulars whereof are given above is required for public purpose i.e for construction of PMGSY road from Ari Upper to Sarhooti; and

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that the land measuring 03 Kanal 09 Marla situated at village Sarhooti, Tehsil Mendhar, District Poonch is required for public purposes viz. construction of Road from Ari upper to Sarhooti, by PMGSY. Further, the Collector Land Acquisition (SDM), Mendhar is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/rules;

However, the Collector concerned shall be specifically responsible for identification and proper title verification of all types of lands involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
