Appointment against the post of Class-IV in Revenue Department under Prime Minister's Special Package for Return and Rehabilitation of Kashmiri Migrants to Kashmir Valley.

Government Order No: Rev/ MR/34 of 2015 Dated: - 16 - 02 - 2015

As recommended by the Selection Committee constituted vide Government Order No. Rev/MR/33 of 2010 dated: 18.2.2010, sanction is hereby accorded to the temporary appointment of the candidates, as per Annexure "A" to this Government order, as Class-IV in pay scale of Rs. 4440-7440 with Grade pay of Rs. 1300/- in the Revenue Department against the posts created vide Government order No. Rev/MR/147 of 2009 dated: 28.10.2009 under Hon'ble Prime Minister Special Package for Return of Kashmiri Migrants to Kashmir Valley and their Rehabilitation therein.

The appointees shall report to the Deputy Commissioner of the concerned District wherefrom they had migrated within a period of 21 days from the date of issuance of this order and the Deputy Commissioner concerned shall utilize their services in their offices or in the newly created administrative units. The address and the Districts wherefrom the candidates had migrated can be verified from the Permanent Resident Certificate of the appointees.

The selected candidates shall be allowed to join only after he/she executes an agreement in the "Form" prescribed under Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules, 2009, issued under notification SRO, 412 of 2009 dated: 30.12.2009, besides, production of following certificates/ documents in original;-

- 1. Academic/ Technical Qualification Certificates.
- Date of Birth Certificate.
- Health Certificate issued by the Competent Authority.
- Permanent Resident Certificate.
- Relevant Category certificate (For reserved category).
- Certificate from General Manger, DIC, concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.
- Migration Certificate of being a Kashmiri Migrants duly issued by Relief & Rehabilitation Commissioner, Migrants.

In case any appointee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointments shall be subject to the following conditions:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/ her character and antecedents is received from the Additional Director General of Police, CID, Jammu and Kashmir, to whom a reference shall be made by the concerned office,, his/her appointment shall by itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment.
- b) The verification of qualification certificate/reserved category certificate (wherever applicable from the concerned issuing authority). The appointment shall be cancelled and treated as such abinito, if any fake / forged documents were proved at any time during service of the candidate.

The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (a) and (b) above is received.

In case the appointee migrates from Kashmir valley at any time during his/her service tenure, for any reason whatsoever, his appointment /service shall stand terminated without any notice by itself by the action of his/her migration.

The appointee shall be on probation initially for a period of two years.

The select list is further subject to the outcome of writ petition (S), if any, in the Hon'ble Court
