As recommended by the J&K, Service Selection Board, sanction is hereby accorded to the temporary appointment of 44 candidates as Junior Assistant, as per Annexure "A" to this order, in Relief and Rehabilitation Organization Department in Kashmir Valley in the pay scale of Rs. 5200-20,200 (Grade pay -1900), under Hon'ble Prime Minister Special Package for return of Kashmiri Migrants to Kashmir Valley and their Rehabilitation therein.

The appointees shall report to the Relief and Rehabilitation Commissioner (Migrants) within a period of 30 days from the date of issuance of this order and Relief and Rehabilitation Commissioner (Migrants) shall further direct them to report concerned Deputy Commissioner's where from they have migrated or as per the address mentioned in his/her PRC(s). He/ She shall be allowed to join only after he/She executes an agreement in the "Form " prescribed under Jammu and Kashmir , Kashmiri Migrants (Special Drive) Recruitment Rules, 2009, issued under notification SRO No. 412 of 2009 dated: 30.12.2009 subject to the production of following certificates/ documents in original:-

- 1. Academic/ Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by the Competent Authority.
- 4 Permanent Resident Certificate.

5. Relevant Category certificate (in case the candidate belongs to reserved category).

6. Certificate from General Manger, DIC, concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.

7. Migration Certificate of being a Kashmiri Migrants duly issued by Relief & Rehabiliation Commissioner, Migrants.

In case any appointee fails to join within the stipulated period of 30 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be further subject to the following conditions:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/ her character and antecedents is received from the Additional Director General of Police, CID, Jammu and Kashmir, to whom a reference shall be made by the concerned office, his/her appointment shall by itself stand cancelled ab-initio and he/she shall have no claim of his/her appointment.
- b) The verification of qualification certificate/reserved category certificate (wherever applicable) from the concerned issuing authority.

The salary of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (a) and (b) above is received.

In case the appointee migrates from Kashmir valley again at any time during his/her service tenure, for any reason whatsoever, his appointment /service shall stand terminated without any notice by itself by the action of his/her migration.

The appointee shall be on probation initially for a period of two years.
