Whereas, the General Administration Department vide U.O. No.GAD(Adm)/300/2014 dated: 20-03-2015 has conveyed that the claim put forth by Ms Nusrat, Tehsildar regarding her promotion on retrospective basis is not covered under rules.

The date of birth shown in the final seniority list shall not be taken as authenticated and is subject to further verification from original Matriculation certificate/ Service Book.




