i. The land is transferred on as is where is basis and shall be used only for the purpose of saturation of 4G Mobile Services by BSNL after obtaining all other permissions as may be required for construction from the Competent Authority.

ii. All the provisions of laws relating to Revenue/Forest/Housing & Urban Development Department, Jal Shakti Department etc and J&K Water Resources (Regulation and Management) Act, 2010 shall be adhered by the user

iii. If any land found part of water course/source etc. shall not be put to any use.

iv. This order shall not debar any competent authority to take legal action in case of violation by the indenting department on the field relating to usage of land.
