- i) Reimbursement of charges is restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof is restricted to the extent of rates applicable to such items procedures at PGI Chandigarh/AIIMS.
- ii) All relevant medical bills/vouchers are verified and countersigned by the competent medical authority of the hospital where from treatment has been undertaken;
- iii) Follow-up(s), if any is/are regulated under rules;
- iv) Essentiality Certificate issued by the hospital authorities.
- v) Certificate from the competent medical authority (Director Health Services/Principal GMC/other) to certify that the drugs and services charges are reasonable and to establish the genuineness of the treatment availed.


