

In terms of proviso to sub-section (1) of section 4 of the Jammu and Kashmir Land Grants Act 1960, read with Rule 7 (a) and (b) of the J&K Land Grants Rules, 1960, sanction is hereby accorded to the renewal of lease of Nazool land (initially leased out by the then Maharaja of Jammu & Kashmir in the Year 1937) measuring 95 Kanals, 04 Marlas and 57 Sft, under Khasra Nos. 1306 to 1315 and 1317 to 1323, situated in village Nursing Garh, Tehsil South, Srinagar, for the last and final term of 19 years w-e-f 13-05-2017, in favour of the Kashmir Catholic Church, Rajbagh, Srinagar (Presentation Convent Higher Secondary School, Srinagar), subject to the payment of enhanced ground rent @ 150% on the existing (fixed) rent per annum.
