The appointee shall report to Financial Commissioner, (Revenue), J&K, within 21 days from the date of issuance of this order, who shall allow the candidate to join on production and verification of the following certificates / documents in original and fulfillment of all other codal formalities as required under rules:-

1. Academic Qualification Certificate.
2. Age & Health Certificate.
3. Permanent Resident Certificate.
4. No loan certificate under self employment scheme from DIC concerned and Employment Department.
5. Dependent Certificate issued by the Deputy Commissioner, Anantnag.
6. All other relevant documents as required under SRO-43 of 1994.

The appointee shall be on probation for a period of two years. If on verification certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID.
