Whereas on the basis of an indent placed by Supdt. of police, District Kishtwar, a notification under section 4(1) was issued by Collector Land Acquisition (ADC), Kishtwar vide No.ADCK/LA/445-50 dated: 15-12-2010 for land measuring **14 Kanals and 14 Marlas**, situated at village "Inshan" Tehsil Warwan, District Kishtwar;

Whereas the Collector Land Acquisition (ADC) Kishtwar vide No. aDCK/LA/437-38 dated: 10-11-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by Collector Land Acquisition (ADC) Kishtwar vide referred to above duly endorsed by Deputy Commissioner, Kishtwar vide No.DCK/LA/233-37/2016 dated: 12-11-2016 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are given in "Annexure-A" to this notification, is required for public purpose viz. for Construction of Police Station/Guest House/Transit Camp Warwan at village Inshan, Tehsil Warwan, District Kishtwar;
