Whereas , on the basis of indent prepared by Executive Engineer , PMGSY Division, Budhal vide No. 676-79 dated 23-07-2013, a notification under section 4 (1) was issued by, Collector, Land Acquisition (SDM) Koteranka vide No. AC/LA/492-94 dated. 29-07-2013, for land measuring <u>02 Kanals and 09 Marlas</u>, situated in village Pori Gujjran, Tehsil Kotranka, District Rajouri;

Whereas, the Collector Land Acquisition, (ACR) Rajouri, vide No. AC/LA/863-64 dated 01-10-2013, has reported that the notification issued under section 4 (1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 &5 –A of the Land Acquisition Act; and

Whereas, the report furnished by Collector Land Acquisition (ACR) Rajouri, vide above referred letter, duly endorsed by District Collector (DC) Rajouri, vide No. AC/LA/508-10 dated 06-01-2017, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz for construction of Road from Sabji to Chalal Bagla under PMGSY;

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that the land measuring <u>O2 Kanals and O9 Marlas</u>, situated in village Pori Gujjran, Tehsil Kotranka, District Rajouri, particulars whereof are given above, is required for public purposes viz for construction of Road from Sabji to Chalal Bagla under PMGSY. Further, the Collector Land Acquistion (SDM) Kotranka, is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (S) as required under the Land Acquisition Act/rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
