Whereas on the basis of an indent placed Deputy Chief Engineer Construction, Northern Railway Banihal vide No.W-15/DYCE/C/Sang/LF-2 dated: 12-05-2010 a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Gool vide No.146-55/SDM/G/Rly dated: 14-01-2016 for land measuring 03 Kanals and 02 Marlas, situated in village "Dharam", Tehsil Gool, District Ramban;

Whereas the Collector Land Acquisition (SDM) Gool vide No. SDM/G/Rly/24-28 dated: 09-06-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, **but no objection was received within the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (SDM) Gool vide No. referred above duly endorsed by Deputy Commissioner, Ramban, vide No.DC/LA/Rbn/16/22 dated:27-09-2016 has been examined and it has been found that the land owners/ interested persons did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are, mentioned are above is required for public purpose viz. "for construction of Dumping Yard for T-47 P1 Dharam;

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **03 Kanals and 02 Marlas** situated in village "**Dharam**", Tehsil Gool District Ramban, particulars whereof are given in "**Annexure -A**" to this notification is required for **public purpose viz. "for construction of Dumping Yard for T-47 P1 Dharam"**. Further, the Collector Land Acquisition (SDM) Gool, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
