

Whereas on the basis of indent prepared by Deputy Chief Engineer/Chenab/USBRL, Northern Railway, Jammu Tawi a notification under section 4 (1) was issued by Collector, Land Acquisition (ADC) Reasi, vide No. COL/LA/ADC/Rsi/16/93-98/NSQ dated 17-06-2016, for land measuring **56 Kanals & 03 Marlas situated in Village Bakkal Tehsil Bhomag, District Reasi;**

Whereas the Collector Land Acquisition (ADC) Reasi vide No. COL/LA/ADC/Rsi/16/252-55/NSQ dated 05-11-2016 has reported that the notification issued under section 4 (1) of the Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act;



Whereas the report furnished by Collector Land Acquisition (ADC) Reasi, vide his letter referred to above duly endorsed by District Collector, (DC) Reasi, vide No. DC/RSI/16-17/853-57/SQ dated 08-11-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., for dumping yard at Bakkal end situated in village Bakkal, Tehsil Bhomag, District Reasi;

Now, therefore, in pursuance of **Section 6** of the J&K Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **56 Kanals & 03 Marlas situated in Village Bakkal, Tehsil Bhomag & District Reasi** particulars whereof are given above is required for public purposes viz. for dumping yard at Bakkal end in village Bakkal Tehsil Bhomag & District Reasi. Further, the Collector Land Acquisition (ADC), Reasi is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
