Whereas on the basis of indent placed by Assistant Defence Estate Officer Rajouri vide No. JRK/203/HRG/Ved Parkash/ HC/CC dated 19-10-2016, a notification under section 4 (1) was issued by, Collector, Land Acquisition, Defence, Rajouri vide No. Coll/Def/76-82 dated 20-10-2016, for land measuring **02 Kanals and 16 Marlas**, situated in village Talwal, Tehsil Rajouri, District Rajouri;

Whereas the Collector Land Acquisition, Defence, Rajouri, has reported that the notification issued under section 4 (1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act;

Whereas, the report furnished by Collector Land Acquisition Defence, Rajouri vide above referred letter, duly endorsed by District Collector (DC) Rajouri, vide No. Coll/Def/147-49 dated 7-11-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are given above, is required for public purpose for acquisition of hired land under Army case No. JKR/03/Hrg..

Now, therefore in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that the land measuring 02 Kanals and 16 Marlas, situated in village Talwal Tehsil Rajouri, District Rajouri, particulars whereof are given above, is required for public purposes viz for for acquisition of hired land under Army case No. JKR/03/Hrg. Further, the Collector Land Acquisition Defence, Rajouri, is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (S) as required under the Land Acquisition Act/rules.


