Whereas on the basis of an indent placed Executive Engineer, PMGSY Division, Budhal vide No.435-38 dated: 13-06-2013, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Rajouri, vide No.AC/LA/1178-80 dated: 10-12-2013 for land measuring 03 Kanals and 16 Marlas, situated in village "Leeran", Tehsil Darhal, District Rajouri;

Whereas the District Collector (DC) Rajouri vide No. AC/LA/357-58 dated: 11-11-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector Land Acquisition (ACR) Rajouri was served upon the interested persons for filing objections, if any, to the proposed acquisition, but no objection was received within the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by District Collector (DC) Rajouri vide No. referred above has been examined and it has been found that interested persons did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purposes viz. "for construction of road from

Ujhan to Leeran in village Leeran, Tehsil Darhal, District Rajouri under PMGSY;

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **03 Kanals and 16 Marlas**, situated in village "**Leeran**", Tehsil Darhal, District Rajouri, particulars whereof is given above is required for **public purpose viz. for construction of road from Ujhan to Leeran in village Leeran under PMGSY**. Further, the Collector Land Acquisition (ACR) Rajouri is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
