Whereas on the basis of an indent placed by Executive Engineer, PWD(R&B) Constt. Div.-II Jammu , a notification under section 4(1) was issued by Collector Land Acquisition (PWD) Jammu vide No. LA/1035-43 dated: 23-12-2016 for land measuring 12 Marlas and 08 Sirsai, situated in village Top Sherkhanian, Tehsil & District Jammu;

Whereas the Collector Land Acquisition (PWD) Jammu vide No. LA/1184-85 dated: 27-01-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (PWD) Jammu vide number referred to above duly endorsed by Deputy Commissioner, Jammu vide No. DCJ/LA/Top Sherkhanian Road/2017-18/1366 dated: 30-12-2017, Divisional Commissioner, Jammu vide No.502/3009/Acq/PWD/Top Sherkhanian/Jmu/18/4418-20 dated: 06-02-2018 and by Financial Commissioner, Revenue vide No. FC-LS/LA-4612/2018 dated: 21-02-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for construction of Upper Shiv Nagar road in village Top Sherkhania, Tehsil & District Jammu by PW(R&B) Department;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 12 Marlas and 08 Sirsai, situated in village Top Sherkhania, Tehsil & District Jammu, particulars whereof are given above is required for public purpose viz. for construction of Upper Shiv Nagar road in village Top Sherkhania, Tehsil & District Jammu by PW(R&B) Department. Further, the Collector Land Acquisition (PWD) Jammu is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.



