Whereas on the basis of an indent placed by Director, Animal Husbandry Department, Jammu vide No. DAHJ/ P & S/4584-85 dated: 14-09-2017, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Doda vide No. 1139-46/Acq dated: 08-11-2017 for land measuring 8 ½ Marlas, situated in village Mundhar, Tehsil Kastigarh, District Doda:

Whereas the Collector Land Acquisition (ACR) Doda vide No. 1455-60/Acq dated: 06-01-2018 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition but **no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (ACR) Doda vide number referred to above duly endorsed by Deputy Commissioner, Doda vide No. 589/LAC/D/17 dated: 17-01-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given above is required for **public purpose viz.** for construction of Veterinary Dispensary Kastigarh in village Mundhar, Tehsil Kastigarh, District Doda by Animal Husbandry Department;

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **8 ½ Marlas**, situated in village Mundhar, Tehsil Kastigarh, District Doda, particulars whereof are given above is required for **public purpose viz. for construction of Veterinary Dispensary Kastigarh by Animal Husbandry Department.** Further, the Collector Land Acquisition (ACR) Doda is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
