Whereas on the basis of an indent placed by Executive Engineer, PMGSY, Division Doda vide No. PMGSY/D/2798-01 dated: 14-12-2016 duly confirmed by Chief Engineer, PMGSY(JKRRDA), Jammu vide No. CEJ/PMGSY/J/9847-49 dated: 16-08-2017, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Doda vide No. 1013-19/Acq dated:20-12-2016 for land measuring 01 Kanals and 07 Marlas, situated in village **Gadi**, Tehsil Bhagwah, District Doda;

Whereas the Collector Land Acquisition (ACR) Doda vide No. 1514-19/Acq dated: 11-01-2018 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (ACR) Doda, vide number referred to above duly endorsed by Deputy Commissioner, Doda vide No. 590/LAC/D/17 dated: 17-01-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz for construction of road from Turning point to Gadi, part B in KM 10<sup>th</sup> in village Gadi, Tehsil Bhagwah, District Doda under PMGSY;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 01 Kanals and 07 Marlas, situated in village Gadi, Tehsil Bhagwah, District Doda, particulars whereof are given above is required for public purpose viz for construction of road from Turning point to Gadi, part B in KM 10<sup>th</sup> in village Gadi, Tehsil Bhagwah, District Doda under PMGSY. Further, the Collector Land Acquisition (ACR) Doda, is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
