Whereas , on the basis of indent prepared by Executive Engineer , PMGSY Division, Doda-II (Kishtwar), a notification under section 4 (1) was issued by Collector, Land Acquisition (ADC) Kishtwar, vide No. ADC/LA/75-80/2016 dated 14-06-2016, for land measuring 02 Kanals and 04 Marlas, situated in village Village Mulwarwan, Tehsil Warwan, District Kishtwar.

Whereas, the Collector Land Acquisition , Kishtwar vide No. ADCK/LA/2016/441-42 dated. 10-11-2016, has reported that the notification issued by him under section 4 (1) of the J&K State land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, **no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act.**

Whereas, the report furnished by Collector Land Acquisition (ACR) Kishtwar, vide above referred letter duly endorsed by District Collector, (DC) Kishtwar, vide No. DCK/LA/283-87/2016 dated 12-11-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz construction of Mulwarwan to Nowpachi road in Village Mulwarwan, Tehsil Warwan and District Kishtwar.

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat 1990, it is declared that the land measuring 02 Kanals and 04 situated at Village Mulwarwan, Tehsil Warwan, District Kishtwar., particulars whereof are given above, is required for public purposes viz for construction of Mulwarwan to Nowpachi road in Village Mulwarwan, Tehsil Warwan, District Kishtwar. Further, the Collector Land Acquisition (ADC), Kishtwar is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (S) as required under the Land Acquisition Act/rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
