Whereas the land, specification whereof are given below is required for public purpose, viz. for widening / four laning of Jammu Akhnoor road by NHIDCL in village Malpur, Tehsil Bhalwal, District Jammu;

Whereas , on the basis of indent placed by General Manager (P) NHIDCL, a notification under section 4 (1) was issued by Collector, Land Acquisition (SDM North),Jammu vide No. SDM/JN/LA/2017-18/102-108 dated 20-11-2017 for land measuring 166 Kanals and 05 Marlas and Subsequent Corrigendum vide No. SDM/JN/LA/2017-18/671 dated 30-12-2017 situated at village Malpur, Tehsil Bhalwal, District Jammu;

Whereas, the Collector Land Acquisition (SDM North) Jammu vide No. SDM/JN/LA/2017-18/676-677 dated 09-01-2018 has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act; and

Whereas, the report furnished by Collector Land Acquisition (SDM) North Jammu, vide above referred letter duly endorsed by District Collector, (DC) Jammu, vide No. DCJ/LA/J-A Road/Malpur/2017-18/1491-92 dated 15-01-2018 and by Divisional Commissioner, Jammu vide No. 502/3042/Acq/NHIDCL/Malpur/J/4261-63 dated 15-02-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz. for widening / four laning of Jammu Akhnoor road by NHIDCL in village Malpur, Tehsil Bhalwal, District Jammu.

Whereas, the indenting department/Collector have expressed urgency for taking over the possession of the land.

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring 166 Kanals and 05 Marlas, situated at village Malpur, Tehsil Bhalwal, District Jammu, particulars whereof are given above, is required for public purposes viz. widening / four laning of Jammu Akhnoor road by NHIDCL in village Malpur, Tehsil Bhalwal, District Jammu. Further, the Collector Land Acquisition (SDM North), Jammu is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

Further, in pursuance of section 17 of the Land Acquisition Act, Samvat 1990, it is also ordered that on expiry of fifteen days from the publication of the Notification under Section 9 (2) of the said Act, the Collector will take possession of the aforementioned land in village Malpur, Tehsil Bhalwal, District Jammu, required for public purposes, subject the fulfillment of the conditions prescribed under Section 9 2) and Section 17-A of the Land Acquisition Act and Rule 63 of the Land Acquisition Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
