Whereas on the basis of indent prepared by Executive Engineer, PWD (R&B) Spl -Division Gandoh vide No. EE/PWD/S/S/D/G/1890-96 dated 14-11-2013, a notification under section 4 (1) was issued by Collector, Land Acquisition (SDM), Gandoh vide No. 461-66/LAC dated 05-10-2015 for land measuring **07 Kanals and 04 Marlas situated in village Bhatyas, Tehsil Chilly Pingal, District Doda;**

Whereas the Collector Land Acquisition (SDM) Gandoh vide No. 285-86/LAC dated 24-09-2016 has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act; and

Whereas the report furnished by Collector Land Acquisition (SDM) Gandoh, vide above referred letter duly endorsed by District Collector, (DC) Doda, vide No. 382/LAC/D/16 dated 20-10-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Further, the Collector Land Acquisition (SDM), Gandoh is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
