Whereas on the basis of an indent placed Executive Engineer, PMGSY Division Doda vide No.PMGSY/D/1491-93 dated: 14-09-2015 a notification under section 4(1) was issued by Collector Land Acquisition (ACR), Doda vide No.895-901/Acq dated: 30-10-2015 for land measuring 06 Kanals and 13 Marlas, situated in village "Dhandal", Tehsil Kastigarh, District Doda;

Whereas the Collector Land Acquisition (ACR) Doda vide No. 1040-45/Acq dated: 23-12-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, **but no objection was received within the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (ACR) Doda vide No. referred above duly endorsed by Deputy Commissioner, Doda, vide No.460/LAC/D/16 dated:12-01-2017 has been examined and it has been found that

except one land owners, the other interested persons did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are mentioned are above is required **for public purposes viz. for construction of road from Saras to Kastigarh in village Dhandal (Lahari), Tehsil Kastigarh, District Doda under PMGSY;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 06 Kanals and 13 Marlas, situated in village "Dhandal ", Tehsil Kastigarh, District Doda, particulars whereof are given above is required for **public purpose viz. for construction of road from Saras to Kastigarh under PMGSY**. Further, the Collector Land Acquisition (ACR) Doda is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
