Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division Doda, duly confirmed by Chief Engineer, PMGSY(JKRRDA),Jammu vide his No. CEJ/PMGSY/J/9792-94 dated: 12-08-2017, a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Thathri vide No. SDM/T/LAC/145-51 dated: 25-09-2017 for land measuring 33 Kanal and 12Marlas, situated in village Halaran, Tehsil Kahra, District Doda;

Whereas the Collector Land Acquisition (SDM) Thathri vide No. SDM/T/LAC/242 dated: 15-12-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by Collector Land Acquisition (SDM) Thathri vide number referred to above duly endorsed by Deputy Commissioner, Doda vide No. 667LAC/D/17 dated: 03-02-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition :

Whereas the Government is satisfied that the land particulars whereof are given above is required **for public purpose viz. for construction of road from Km 1st RD 600 of LO 26 to Joura Khurd in village Halaran, Tehsil Kahra, District Doda under PMGSY;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **33 Kanal and 12Marlas**, situated in village Halaran, Tehsil Kahra, District Doda, particulars whereof are given above is required for **public purpose viz. for construction of road from Km 1st RD 600 of LO 26 to Joura Khurd in village Halaran, Tehsil Kahra, District Doda under PMGSY**. Further, the Collector Land Acquisition (SDM) Thathri is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
