Whereas the land specifications whereof are given in "Annexure "A" to this notification is required for public purpose viz. for Construction of Corridor to Islamic University of Science & Technology in village & Tehsil Awantipora, District Pulwama;

Whereas on the basis of an indent placed by Registrar, Islamic University of Science & Technology, Awantipora vide NoIUST/LA/15/10012-14 dated:31-12-2015, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Pulwama vide No.DCP/LA/972-77/pul dated:12-01-2016 for land measuring 13 Kanals, 19 Marlas & 07 Sirsai, situated in village & Tehsil Awantipora, District Pulwama;

Whereas the Collector Land Acquisition (ACR) Pulwama vide No. DCP/LA/2017/1109-13 dated: 23-11-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by Collector Land Acquisition (ACR) Pulwama vide No. referred above duly endorsed by Deputy Commissioner, Pulwama vide No.DCP/LA/2017/1157-60 dated: 13-12-2017, Divisional Commissioner, Kashmir vide No. DivCoc/LAS-Acq/3064/3772 dated: 15-01-2018 and by Financial Commissioner, Revenue vide No. FC-LS/LA-4608/2018 dated: 30-01-2018 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given in "Annexure-A" to this notification, is required for public purpose viz. for Construction of Corridor to Islamic University of Science & Technology Awantipora, Tehsil Awantipora, District Pulwama;



Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 13 Kanals, 19 Marlas & 07 Sirsai, situated in village & Tehsil Awantipora, District Pulwama, particulars whereof are given in "Annexure -A" to this notification, is required for public purposes viz. for Construction of Corridor to Islamic University of Science & Technology Awantipora, Tehsil Awantipora, District Pulwama. Further, the Collector Land Acquisition (ACR) Pulwama is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.

Now, in pursuance of section 17 of the Land Acquisition Act, Samvat 1990, it is ordered that on expiry of fifteen days from the publication of the notification under section 9(2) of the said Act, the Collector will take possession of the aforementioned land in village & Tehsil Awantipora, District Pulwama required for public purpose, subject to fulfillment of the conditions prescribed under section 9(2) and section 17-A of the Land Acquisition Act and Rule 63 of the Land Acquisition Rules;

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
