Whereas on the basis of indent prepared by Executive Engineer, PMGSY, Division Ramnagar vide No. PMGSY/Div/Rgr/1830-33 dated 08-03-2012, a notification under section 4 (1) was issued by Collector, Land Acquisition (ACR) Udhampur, vide No. PMGSY/Chenani/ 287-94 dated 01-02-2014, for land measuring **09 Kanals, 01 Marlas situated in Village Sira, Tehsil Latti Marothi, District Udhampur;**

Whereas the Collector Land Acquisition (ACR) Udhampur has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act.

Whereas the report furnished by Collector Land Acquisition (ACR) Udhampur, vide above referred letter duly endorsed by District Collector, (DC) Udhampur, vide No. DCU/SQ/PMGSY/3125-27 dated 01-12-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., construction of road under PMGSY from "Upper Battal Ballian to Ladialya" Phase-VIII in village Ladialya Tehsil and District Udhampur.

Now therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **09 Kanals, 01 Marlas situated in Village Sira Tehsil Latti Marothi, District Udhampur**, particulars whereof are given above, is required for public purposes viz. for Further, the Collector Land Acquisition (ACR), Udhampur is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
