Whereas on the basis of an indent placed by Director, Horticulture (P&M) Department vide No.DHPM/701/2013/6777-79 dated: 20-03-2014 a notification under section 4(1) was issued by Collector Land Acquisition (ACR), Kathua vide No.DCK/LA/ACR/2013-14/574-81 dated: 19-06-2014 for land measuring 01 Kanal, situated at village "Taraf Manjali", Tehsil & District Kathua;

Whereas District Collector (DC) Kathua vide his letter No. DCK/LA/2016-17/4013-15 dated:30-11-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was issued by Collector Land Acquisition (ACR) was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by the Deputy Commissioner, Kathua, vide No. referred to above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for establishment of Satellite Fruit and Vegetable Market situated at village Taraf Manjli, Tehsil & District Kathua;

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Svt, 1990, it is declared that land measuring **01 Kanal**, situated in village "**Taraf Manjli**", Tehsil & District Kathua, particulars whereof are given above, is required for **public purpose viz. for establishment of Satellite Fruit and Vegetable Market**. Further, the Collector Land Acquisition,(ACR) Kathua, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
