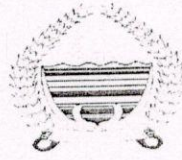

Whereas, on the basis of an indent placed by Officer Commanding, 79 RCC(GREF) vide datd:08-05-2006 a notification under section 4(1) was issued by Collector Land Acquisition (Defence), Rajouri/Poonch, HQ Rajouri vide No.Coll/Def/811-15 dated:24-10-2011 for land measuring **33 Kanals and 08 Marlas**, situated in village "Chandak", Tehsil Haveli, District Poonch;

Whereas, District Collector (Deputy Commissioner) Poonch vide his letter No. Coll/Def/325 dated:11-07-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas, the report furnished by the Deputy Commissioner, Poonch vide No.Coll/Def/325 dated: 11-07-2016 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition : and

Whereas, the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for Widening of Jammu- Poonch D/L road by GREF.

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Svt, 1990, it is declared that land measuring 33 Kanals and 08 Marlas, situated in village "Chandak", Tehsil Haveli District Poonch, particulars whereof are given above, is required for public purpose viz. for Widening of Jammu- Poonch D/L road by GREF. Further, the Collector Land Acquisition,(Defence),Rajouri /Poonch, HQ Rajouri, is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
