Whereas on the basis of an indent placed by Executive Engineer, PW(R&B) Division, Poonch, a notification under section 4(1) was issued by Collector Land Acquisition (ACR), Poonch vide No. DCP/LA/437-45 dated: 01-08-2016 for land measuring 13 Kanal, 13 Marlas and 08 Sarsai, situated in village "Shehar Khaas" Tehsil Haveli, District Poonch;

Whereas the District Collector (DC) Poonch, vide No. DCP/LA/946 dated: 18-11-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector Land Acquisition (ACR) Poonch vide No. referred above was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by District Collector (DC) Doda, vide his letter to referred above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are mentioned in above is required for public purpose viz. for Construction of road from main road chungi to near the House of Abu Kalam S/O Nazam Din at village Shehar Khaas, Tehsil Haveli, District Poonch by PWD;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 13 Kanal, 13 Marlas and 08 Sarsai, situated in village "Shehar Khaas" Tehsil Haveli, District Poonch, particulars whereof are given above is required for public purpose viz. for Construction of road from main road chungi to near House of Abu Kalam S/O Nazam Din by PWD. Further, the Collector Land Acquisition (ACR) Poonch is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
