Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division, Rajouri vide EE/PMGSY/R/824 datd:27-09-2016, a notification under section 4(1) was issued by Collector Land Acquisition (SDM), Sunderbani vide No. SDM/SB/2016-17/560-564 dated: 02-11-2016 for land measuring 01 Kanal and 14 Marlas, situated in village "**Langer**", Tehsil Sunderbani , District Rajouri;

Whereas the District Collector (DC) Rajouri vide No.AC/LA/518-20 dated: 06-01-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector Land Acquisition (SDM), Sunderbani vide No. SDM/SB/2016-17/560-564 dated: 02-11-2016 was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by District Collector (DC) Rajouri vide referred above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for construction of road from Mawa to Langer under PMGSY;

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **01 Kanal and 14 Marlas**, situated in village "**Langer**", Tehsil Sunderbani District Rajouri, particulars whereof is given above is required for **public purpose viz. for construction of road from Mawa to Langer under PMGSY**. Further, the Collector Land Acquisition,(SDM) Sunderbani is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
