Whereas , on the basis of indent prepared by Executive Officer, Municipal, Committee Doda, a notification under section 4 (1) was issued by Collector, Land Acquisition (ACR), Doda vide No. 508-14/Acq dated 19-08-2015, for land measuring ~~03~~ 03 1/3 Marlas situated at village Doda, Tehsil & District Doda; and

Whereas, the Collector Land Acquisition (ACR) Doda vide No. 508-14/Acq has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act; and

Whereas, the report furnished by Collector Land Acquisition (ACR) Doda, vide above referred letter duly endorsed by District Collector, (DC) Doda, vide No. 355/LAC/D/16 dated 10-11-2016, has been examined and it has been found that some of the interested persons filed their objections to the acquisition, which have been considered and found not tenable as the land is required for public purposes.



Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., construction of drain from College road to H/o Abdul Qayoom R/o Nagri.

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **03, 1/3 Marlas situated at village Doda, Tehsil & District Doda.**, particulars whereof are given above, is required for public purposes viz. for construction of drain from College road to H/o Abdul Qayoom R/o Nagri. Further, the Collector Land Acquisition (ACR), Doda is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
