Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division, Budhal vide No. EE/PMGSY/B/337-39 datd:01-05-2016 a notification under section 4(1) was issued by Collector Land Acquisition (SDM) Thanamandi vide No.SDM/TM/PMGSY/229-32 dated:12-07-2016 for land measuring 09 Kanals and 10 Marlas, situated in village "Kalas", Tehsil Thanamandi, District Rajouri;

Whereas District Collector (Deputy Commissioner) Rajouri vide his letter No. AC/LA/423-24 dated:02-12-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector Land Acquisition (SDM) Thanamandi was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by the Deputy Commissioner, Rajouri vide No. referred to above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are given above is required for public purpose viz. for construction of road from lower Manyal to Darra in village Kalas, Tehsil Thanamandi, District Rajouri under PMGSY;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Svt, 1990, it is declared that land measuring 09 Kanals and 10 Marlas, situated in village "Kalas", Tehsil Thanamandi District Rajouri, particulars whereof are given above, is required for public purpose viz. for construction of road from lower Manyal to Darra in village Kalas, Tehsil Thanamandi, District Rajouri under PMGSY. Further, the Collector Land Acquisition (SDM) Thanamandi, is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
