Whereas the land specifications whereof are given in "Annexure "A" to this notification, is required for **public purpose viz. for Construction of road from Dellar Payein to Dellar Balla in village Chhatroo, Tehsil Chhatroo , District Kishtwar, unde PMGSY;**

Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division Doda-II Kishtwar vide No.PMGSY/D-II/375-79 datd:24-05-2008, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Kishtwar vide No.ACR/LA/83-88 dated: 17-06-2013 for land measuring 14 Kanals and 13 Marlas read with de-notification vide No. ACR/LA/16/K/35-41 dated: 04-08-2016 for land measuring 05 Kanals and 01 Marla situated in village "Chhatroo", Tehsil Chhatroo, District Kishtwar, thereby keeping the final area as 09 Kanals and 12 Marlas;

Whereas the Collector Land Acquisition (ACR) Kishtwar vide No.ACR/LA/2189 dated: 22-10-2016, has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, **but, no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act; and**

Whereas the report furnished by Collector Land Acquisition (ACR) Kishtwar vide No. referred above and endorsed by Deputy Commissioner, Kishtwar vide DCK/LA/2016/303-07 dated: 12-11-2016 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are mentioned in "Annexure-A" to this notification, is required **for public purpose viz. "for Construction of road from Dellar Payein to Dellar Balla in village Chhatroo, Tehsil Chhatroo, District Kishtwar, under PMGSY;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **09 Kanals and 12 Marlas** situated in village "**Chhatroo**", Tehsil Chhatroo, District Kishtwar particulars whereof are given in "**Annexure -A**" to this notification, is required for **public purpose viz.** for Construction of road from Dellar Payein to Delar Balla under PMGSY in village Chhatroo, Tehsil Chhatroo & District Kishtwar. Further, the Collector Land Acquisition (ACR) Ramban is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
