Whereas on the basis of indent prepared by Executive Engineer, PMGSY Division Doda vide No. PMGSY/D/651-53 dated 16-06-2015, a notification under section 4 (1) was issued by Collector, Land Acquisition (ACR), Doda vide No. 340-47/ACQ dated 18-06-2016 for land measuring **07 Kanals and 07 Marlas situated at village Bharath , Tehsil Bharath Bagla, District Doda;**

Whereas the Collector Land Acquisition (ACR) Doda vide No. 888-93/ACq dated 22-10-2016 has reported that the notification issued under section 4 (1) of the J&K State land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act; and

Whereas the report furnished by Collector Land Acquisition (ACR) Doda, vide above referred letter duly endorsed by District Collector, (DC) Doda, vide No. 420/LAC/D/16 dated 23-12-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition;

Whereas the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., construction of Bagla Dal Draman road in village Bharath, Tehsil Bharath Bagla, District Doda under PMGSY Scheme.

Now therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **07 Kanals and 07 Marlas situated at village Bharath, Tehsil Bharath Bagla, District Doda**, particulars whereof are given above, is required for public purposes viz. for **construction of Bagla Dal Draman road in village Bharath, Tehsil Bharath Bagla, District Doda under PMGSY Scheme**. Further, the Collector Land Acquisition (ACR), Doda is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
