Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division Udhampur vide PMGSY/Div./Udh-I/2404-06 dated: 02-12-2009, a notification under section 4(1) was issued by Collector Land Acquisition (SDM), Ramnagar, vide No. SDMR/LA/2016-17/388-96 dated: 08-10-2016 for land measuring 19 Kanals and 10 Marlas, situated in village "Sughlar", Tehsil Ramnagar, District Udhampur;

Whereas the Collector Land Acquisition (SDM) Ramnagar, vide No.SDMR/LA/2016-17/491 dated: 08-11-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;

Whereas the report furnished by Collector Land Acquisition (SDM) Ramnagar, vide referred to above duly endorsed by Deputy Commissioner, Udhampur vide No.ACRU/SQ/2988-90 dated: 23-11-2016 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are mentioned above is required for public purposes viz. for Construction of road from Jugular to Roa Bagh Phase VII situated in village Sughlar, Tehsil Ramnagar, District Udhampur, under PMGSY;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 19 Kanals and 10 Marlas, situated in village "Sughlar", Tehsil Ramnagar, District Udhampur, particulars whereof are given above is required for public purposes viz. for Construction of road from Sugular to Roa Bagh Phase VII under PMGSY. Further, the Collector Land Acquisition, (SDM) Ramnagar is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
