Whereas the land specifications whereof are given below is required for **public purpose viz. for Dumping Yard at T-5 P-1(alternate proposal) on Katra-Dharm section of the USBRL Project in village Gran, Tehsil & District Reasi;**

Whereas on the basis of an indent placed by Dy.Chief Engineer Chenab/USBRL Nothrn Railway, Reasi vide No. Dy.CE/C/Reasi/T5P1/D.Yard/Land Indent dated:20-02-2017, a notification under section 4(1) was issued by Collector Land Acquisition (ADC) Reasi vide No.Col/LA/ADC/Rsi/17/05-10/NSQ dated:04-04-2017 for land measuring **117 Kanals and 02 Marlas**, situated in village "Gran", Tehsil & District Reasi;

Whereas the Collector Land Acquisition (ADC) Reasi, vide letter No. Col/LA/ADC/Rsi/17/30-33/NSQ dated:19-04-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act.**

Whereas the report furnished by Collector Land Acquisition (ADC), Reasi vide letter referred to above duly endorsed by Deputy Commissioner, Reasi vide No.DC/Rsi/17-18/24-28/SQ dated: 21-04-2017 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are given above is required **for public purpose viz. for Dumping Yard at T-5 P-1(alternate proposal) on Katra-Dharm section of the USBRL Project in village Gran, Tehsil & District Reasi;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Svt, 1990, it is declared that land measuring **117 Kanals and 02 Marlas**, situated in village "**Gran**", Tehsil & District Reasi, particulars whereof are given above is required for **public purpose viz. for Dumping Yard at T-5 P-1(alternate proposal) on Katra-Dharm section of the USBRL Project in village Gran, Tehsil & District Reasi.** Further, the Collector Land Acquisition (ADC) Reasi is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

Further, in pursuance of section 17 of the Land Acquisition Act, Samvat 1990, it is also ordered that on expiry of fifteen days from the publication of the notification under section 9(2) of the said Act, the Collector will take possession of the aforementioned land in village Gran, Tehsil & District Reasi, required for public purpose, subject to fulfillment of the conditions prescribed under section 9(2) and section 17-A of the Land Acquisition Act and Rules 63 of the Land Acquisition Rules;

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
