Whereas the land specifications whereof are given in "Annexure "A" to this notification, is required for **public purpose viz. for construction of road from Lakhari to Drab in village Lakhari, Tehsil Ramkote, District Kathua under PMGSY;**

Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division Billawar, a notification under section 4(1) was issued by Collector Land Acquisition (SDM), Billawar, vide No.SDM/B/2015-16/1801-06 dated: 16-12-2015 for land measuring 52 Kanals and 02 Marlas, situated in village "Lakhari", Tehsil Ramkote, District Kathua;

Whereas the District Collector(DC) Kathua, vide No.DCK/LA/2016-17/6014-18 dated: 20-01-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by (SDM) Billawar, vide number referred to above was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by District Collector (DC) Kathua vide No. referred to above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are mentioned in "Annexure-A" to this notification, is required **for public purpose viz. for construction of road from Lakhari to Drab in village Lakhari, Tehsil Ramkote, District Kathua under PMGSY;**

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 52 Kanals and 02 Marlas situated in village "Lakhari", Tehsil Ramkote, District Kathu, particulars whereof are given in Annexure -A to this notification is required for **public purpose viz. for construction of road from Lakhari to Drab under PMGSY.** Further, the Collector

Land Acquisition,(SDM) Badnota/Billawar, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
