Whereas on the basis of an indent placed by Director Fisheries, J&K vide CJ/2016/3365-68 datd:13-12-2016, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Rajouri, vide No.AC/LA/653-56 dated:08-02-2017 for land measuring **24 Kanals and 05 Marlas**, situated in village "**Badhoon**", Tehsil & District Rajouri;

Whereas the District Collector (DC) Rajouri vide No. AC/LA/07-08 dated:07-04-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by Collector Land Acquisition (ACR) Rajouri vide No. referred to above was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by the District Collector (DC) Rajouri vide No. referred to above duly endorsed by the Divisional Commissioner, Jammu vide No.502/2824/Acq/Badhoon/B-Bank/Agoura/17/189-91 dated: 20-04-2017 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition:

Whereas the Government is satisfied that the land particulars whereof are mentioned above is required **for public purposes viz. for construction of Mahseer Brood Bank in village Badhoon, Tehsil & District Rajouri by Fisheries Department; and**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **24 Kanals and 05 Marlas** situated in village "**Badhoon**", Tehsil & District Rajouri, particulars whereof are given above, is required for **public purposes viz. for construction of Mahseer Brood Bank in village Badhoon, Tehsil & District Rajouri by Fisheries Department.** Further, the Collector Land Acquisition,(ACR) Rajouri, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
