Whereas the land, specifications whereof are given in "Annexure A" to this notification, is required for **public purpose viz. for construction of a Semi Ring Road situated in village Gudsathoo, Tehsil & District Budgam by NHAI;**

Whereas on the basis of an indent placed by Project Director, NHAI vide No.PD/SGR/14010/01/2014/LA-Bdg/13 dated: 20-04-2016, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Budgam vide No. DCB/LAS/016/F-330/11-18 dated:15-04-2017 for land measuring **114 Kanals, 09 Marlas and 40 Sft**, situated in village "Gudsathoo", Tehsil & District Budgam;

Whereas the Collector Land Acquisition (ACR) Budgam vide NoDCB/LAS/016/F-330/593-98 dated:22-06-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, **but, no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act; and**

Whereas the report furnished by the Collector Land Acquisition (ACR) Budgam vide his letter referred to above, duly endorsed by the Deputy Commissioner, Budgam vide No.MCB/LAS/016/F-330/575-79 dated:22-06-2017 and by Divisional Commissioner, Kashmir vide No.Div Com/LAS-Acq/3139/2893 dated: 05-07-2017 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are given in "Annexure-A" to this notification, is required for **public purpose viz. for construction of a Semi Ring Road situated in village Gudsathoo, Tehsil & District Budgam by NHAI;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **114 Kanals, 09 Marlas and 40 Sft**, situated in village "Gudsathoo", Tehsil & District Budgam, particulars whereof are given in "Annexure -A" to this notification is required for **public purpose viz for**

construction of a Semi Ring Road by NHAI. Further, the Collector Land Acquisition,(ACR) Budgam is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.


