Whereas on the basis of an indent placed by Officer Commanding, 79 RCC(GREF), a notification under section 4(1) was issued by Collector Land Acquisition (Defence), Rajouri-Poonch, HQ Rajouri, vide No.Coll/Def/471-76 dated: 13-10-2015 for land measuring **05 Kanals, 18 Marlas and 04 Sarsai**, situated in village "**Kalai**", Tehsil Haveli, District Poonch;

 Whereas the Deputy Commissioner, Poonch vide letter No. Coll/Def/322 dated:11-07-2016, has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by the Collector Land Acquisition (Defence), Rajouri-Poonch, HQ Rajouri, was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Deputy Commissioner, Poonch vide letter referred to above, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and



Whereas the Government is satisfied that the land particulars whereof are given above is required for public purposes viz. for Construction of Bridge at Km 228-300 "Kalai to Chandak on BG Poonch Road" by GREF;

Now, therefore, in pursuance of Section 6 of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring 05 Kanals, 18 Marlas and 04 Sarsai, situated in village "Kalai", Tehsil Haveli, District Poonch, particulars whereof are given above is required for public purposes viz. "for Construction of Bridge at Km 228-300 "Kalai to Chandak on BG Poonch Road" by GREF. Further, the Collector Land Acquisition,(Defence),Rajouri /Poonch, HQ Rajouri is directed under Section 7 of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.




