Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division Banihal vide No. PMGSY/D/B/387-91 datd:02-09-2015, a notification under section 4(1) was issued by Collector Land Acquisition (ACR), Ramban vide No.Acq/PMGSY/16/432-33. dated: 15-11-2016 for land measuring **02 Kanals**, situated in village "Alinbass" Tehsil Pogal Paristan, District Ramban;

Whereas the Collector Land Acquisition (ACR) Ramban, vide No. Acq/PMGSY/2016-17/708-11 dated: 17-03-2017 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by Collector Land Acquisition (ACR) Ramban, vide referred to above duly endorsed by Deputy Commissioner, Ramban vide No. DC/LA/Rbn/82-83 dated:07-04-2017 has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ;

Whereas the Government is satisfied that the land particulars whereof are mentioned in above is required **for public purpose viz. for Construction of Hunga Linbass to Hochak Road in village Alinbass, Tehsil Pogal Paristan, District Ramban under PMGSY;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **02 Kanals**, situated in village "Alinbass " Tehsil, Pogal Paristan, District Ramban particulars whereof are given above is required for **public purpose viz. for Construction of Hunga Alinbass to Hochak Road in village Alinbass, Tehsil Pogal Paristan, District Ramban under PMGSY**. Further, the Collector Land Acquisition,(ACR) Ramban is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

Further, in pursuance of section 17 of the Land Acquisition Act, Samvat 1990, it is also ordered that on expiry of fifteen days from the publication of the notification under section 9(2) of the said Act, the Collector will take possession of the aforementioned land in village Alinbass Tehsil Pogal Paristan, District Ramban required for public purpose, subject to fulfillment of the conditions prescribed under section 9(2) and section 17-A of the Land Acquisition Act and Rules 63 of the Land Acquisition Rules;

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
