Whereas on the basis of an indent placed by Executive Engineer, PMGSY Division, Doda vide PMGSY/D/745-46 datd:26-06-2015, a notification under section 4(1) was issued by Collector Land Acquisition (ACR), Doda vide No. 436-42/Acq dated: 23/07/2015 for land measuring 13 Kanals and 10 Maralas, situated in village "Dhar", Tehsil & District Doda;

Whereas the Collector Land Acquisition (ACR) Doda vide No.833-38/Acq dated: 07-10-2016 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition and some objections in the instant case were received from from the concerned land owners which were properly examined & rejected after having been found devoid of any rent.

Whereas the report furnished by the Collector Land Acquisition (ACR) Doda vide referred to above duly endorsed by Deputy Commissioner, Doda vide No.379/LAC/D/16 dated: 20-10-2016 has been examined and it has been found that the objections filed by the interested persons are not maintainable;

Whereas the Government is satisfied that the land particulars whereof are given above is required **for public purpose viz. for Construction of road from Bharath Kandwah to Aul in village Dhar, Tehsil & District Doda under PMGSY;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **13 Kanals and 10 Marlas**, situated in village **“Dhar”**, Tehsil & District Doda particulars whereof are given above is required for **public purpose viz. for Construction of road from Bharath Kandwah to Aul under PMGSY**. Further, the Collector Land Acquisition, (ACR) Doda is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
