Whereas on the basis of indent placed by Deputy Chief Engineer/Chenab/USBRL, Northern Railway, Jammu Tawi vide No. 1-G/Revenue land/ Indents Chenab dated 01-06-2016, a notification under section 4 (1) was issued by Collector, Land Acquisition (SDM) Mahore, vide No. SDM/M/CLA/NR/A/16-17/18-29 dated 16-06-2016, for land measuring **105 Kanals & 17 Marlas** situated in Village **Kanthan Tehsil Arnas, District Reasi for the aforementioned purpose;**

Whereas the Collector Land Acquisition (SDM) Mahore, vide No. SDM/M/LA/CLA/NR/2016-17/65-66 dated 21-11-2016 has reported that the notification issued under section 4 (1) of the Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act;

Whereas the report furnished by Collector Land Acquisition (SDM) Mahore, vide his letter referred to above duly endorsed by District Collector, (DC) Reasi, vide No. DC/RSI/16-17/1075-76/SQ dated 26-12-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., construction of Mulba Dumping Yard at village Kanthan (Kouri) Tehsil Arnas and District Reasi;

Now, therefore, in pursuance of **Section 6** of the J&K Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **105 Kanals & 17 Marlas situated in Village Kanthan Tehsil Arnas, District Reasi** particulars whereof are given in Annexure-A is required for public purposes viz. for M ulba Dumping Yard at village Kanthan (Kouri) Tehsil Arnas, District Reasi by Northern Railway. Further, the Collector Land Acquisition (SDM), Mahore is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
