Whereas on the basis of an indent placed by Executive Engineer, PMGSY, Division, Budhal vide No.619-22 datd:15-07-2013, a notification under section 4(1) was issued by Collector Land Acquisition (ACR) Rajouri, vide No.AC/LA/724-26

dated:13-09-2013 for land measuring **38 Kanals and 07 Marlas**, situated in village "Karyote", Tehsil Thanamandi, District Rajouri;

Whereas the Collector Land Acquisition (ACR) Rajouri, vide No. AC/LA/1716-17 dated:06-03-2014 has reported that the notification issued under section 4(1) of the J&K State Land Acquisition Act by him was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners /interested persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act;**

Whereas the report furnished by the Collector Land Acquisition (ACR) Rajouri vide No. referred to above duly endorsed by the Deputy Commissioner, Rajouri vide No.AC/LA/359-60 dated: 11-11-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition ; and

Whereas the Government is satisfied that the land particulars whereof are given above is required for **public purposes viz. for construction of road from Manyal to Darra in village Karyote, Tehsil Thanamandi, District Rajouri under PMGSY;**

Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **38 Kanals and 07 Marlas** situated in village "Karyote", Tehsil Thanamandi, District Rajouri, particulars whereof are given above, is required for **public purposes viz. for construction of road from Manyal to Darra, under PMGSY.** Further, the Collector Land Acquisition,(ACR) Rajouri, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested persons(s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.




