Whereas on the basis of indent placed by Officer Commanding 79 RCC(GREF) a notification under section 4 (1) was issued by Collector, Land Acquisition (Defence) Rajouri-Poonch (Headquarter) Rajouri vide No. Coll/Def/972-77 dated 29-03-2016 for land measuring **65 Kanals, 16 Marlas** situated in Village Kalaban, Tehsil Mendhar, District Poonch;

Whereas, the District Collector, Poonch vide No. Coll/Def/1024-25 dated 14-12-2016, has reported that the notification issued under section 4 (1) of the J&K State Land Acquisition Act by Collector, Land Acquisition, (Defence) Rajouri/Poonch was served upon the interested persons for filing objections, if any, to the proposed acquisition, but, no objection was received from the land owners/ interested persons within the prescribed period as required under sections 5 & 5 -A of the Land Acquisition Act.

Whereas, the report furnished by District Collector, (DC) Poonch, vide No. Coll/Def/1024-25 dated 14-12-2016, referred to above has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz., for construction of Shahsitar-KG Top road by GREF.

Now therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that the land measuring **65 Kanals, 16 Marlas** situated in Village Kalaban, Tehsil Mendhar, District Poonch, particulars whereof are given in above, is required for public purposes viz. for construction of Shahsitar-KG Top road by GREF. Further, the Collector, Land Acquisition (Defence) Rajouri-Poonch (Headquarter) Rajouri is directed under section 7 of the said Act to take orders for acquisition of the said land after giving prescribed notice to the interested person (s) as required under the Land Acquisition Act/Rules.

However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case for making apportionment of compensation amongst all the interested persons/ rightful claimants, in accordance with the relevant laws/ rules in force, while making the award.
