Whereas, the land, specifications whereof are given below, is required for **public purpose viz. "Construction of road Pakal-Dul HEP Project"**; and

Whereas, on the basis of an indent placed by General Manager, Pakal-Dul, CVPPP Limited, vide No.CVPPP/PDHEP/GM/Land/2013/DM-5 dated:03-04-2013, accordingly, a notification under section 4 (1) was issued by Collector Land Acquisition (ACR) Kishtwar vide No.ACR/LA/1323-28 dated:20-04-2013, for land measuring **56 Kanals – 09 Marlas**, situated in village "**Kwartanji**", Tehsil & District Kishtwar; and

Whereas, the Collector Land Acquisition (ACR), Kishtwar vide No.ACR/LA/2014/112-113 dated:10-04-2014, has reported that the notification issued under section 4 (1) of the J&K State Land Acquisition Act by him, was served upon the interested persons for filing objections, if any, to the proposed acquisition **but no objection was received from the land owners/interested**

persons in the prescribed time period as required under section 5 & 5-A of the Land Acquisition Act; and

Whereas, notification/declaration under sections 6 & 7 of the Land Acquisition Act was issued by District Collector (DC), Kishtwar, vide No.DCK/LA/306-13 dated:03-01-2015, which was withdrawn by him vide No.DCK/LA/39-41/2016 dated:14-07-2016 in terms of SRO 25 dated:28-01-2016; and

Whereas, the report furnished by Collector Land Acquisition (ACR), Kishtwar, vide letter referred to above, duly endorsed by District Collector, (DC), Kishtwar vide No.DCK/LA/42-46/2016 dated:22-07-2016, and endorsed by Divisional Commissioner, Jammu vide No.a502/2661/Acq/Pakal-Dul-HEPP/Kwartanji/Ktr/16/1201-03 dated:01-08-2016, has been examined and it has been found that the land owners did not file any objection to the proposed acquisition; and

Whereas, the Government is satisfied that the land particulars whereof are given above, is required for public purpose viz. **“Construction of road Pakal-Dul HEP Project”**.


Now, therefore, in pursuance of **Section 6** of the J&K State Land Acquisition Act, Samvat, 1990, it is declared that land measuring **56 Kanals – 09 Marlas**, situated in village **“Kwartanji”**, Tehsil & District Kishtwar, particulars whereof are given above, is required for **public purpose viz. “Construction of road Pakal-Dul HEP Project”**. Further, the Collector Land Acquisition (ACR), Kishtwar, is directed under **Section 7** of the said Act to take order for acquisition of the said land after giving prescribed notice to the interested person(s) as required under the Land Acquisition Act/Rules.



However, the Collector concerned shall be personally responsible for identification and proper title verification of all types of land involved in the case and apportionment of compensation amongst all the interested



persons/rightful claimants in accordance with the relevant laws/rules in force, while making the award.
